Order Granting Plaintiff MVSHQ, Inc.'s Motion To Extend Exclusive Salvage Rights As Salvor-In-Possession Of Defendant Vessel and Injunctive Relief To Prohibit Interference By All Others

UPON DUE CONSIDERATION of Plaintiff, MARTHA'S VINEYARD SCUBA HEADQUARTERS, INC.'s motion filed April 26, 2011 by its attorneys, before this Court and all papers in connection therewith and in opposition thereto, if any, and for good cause shown:

## IT IS ORDERED AND ADJUDGED that

- (I) Plaintiff MARTHA'S VINEYARD SCUBA HEADQUARTERS, INC. is hereby affirmed by this Court as the rightful salvor-in-possession of Defendant Vessel R.M.S. REPUBLIC, her tackle, apparel, appurtenances, and cargo that lie within the area set forth in the pleaded coordinates described in the Verified Complaint previously filed herein;
  - (2) Plaintiff MARTHA'S VINEYARD SCUBA HEADQUARTERS, INC.

previously granted exclusive salvage rights as salvor-in-possession of Defendant Vessel R.M.S. REPUBLIC, her tackle, apparel, appurtenances, and cargo (hereinafter referred to collectively as "Defendant Vessel")that lie within the areaset forth in the pleaded coordinates described in the Verified Complaint previously filed herein, is hereby extended through to and including December 31, 2014;

(3) Plaintiff MARTHA'S VINEYARD SCUBA HEADQUARTERS, INC. prior award of priority salvage status and the sole and exclusive possession of the Defendant Vessel, within the area set forth in the pleaded coordinates described in the Verified Complaint previously filed herein, is continued through to and including December 31, 2014; and

## IT IS FURTHER ORDERED that

- (4) the preliminary injunction previously issued that temporarily enjoins and restrains any and all interference by all others with MARTHA'S VINEYARD SCUBA HEADQUARTERS, INC.'s exclusive rights to recover the Defendant Vessel, within the area set forth in the pleaded coordinates described in the Verified Complaint previously filed herein, is hereby extended through to and including December 31, 2014;
- (5) said preliminary injunction also continues to temporarily enjoin and restrain any interference of all others regarding the recovery, preservation and custody of any and all artifacts by Plaintiff MVSHQ after being adjudged herein as having the sole and exclusive rights to conduct salvage of the Defendant Vessel, through to and including December 31, 2014; and
- (6) alternatively, should any claimant subsequently be adjudged the owner of the Defendant Vessel, or any part of her tackle, apparel, appurtenances and cargo thereof,

that Plaintiff MARTHA'S VINEYARD SCUBA HEADQUARTERS, INC. shall beconferred a liberal salvage award in artifacts or in specie, with the amount and/or composition of such award as may be determined by this Court pursuant to the law of salvage.
